PUBLIC HEARINGS

PROPOSED ORDINANCE NO. 2019-181 RE-ZONING CERTAIN PROPERTY OWNED BY LOUIS BRELAND AND LOCATED WEST OF THE TERMINUS OF KYSER BOULEVARD AND SOUTH OF NORFOLK SOUTHERN RAILROAD FROM M1 (RESTRICTED INDUSTRIAL) AND M2 (GENERAL INDUSTRIAL) TO R3 (HIGH DENSITY RESIDENTIAL) {FIRST READING 06-24-2019}

Council Member Clark recused himself from this portion of the meeting.

Director of Development Services Mary Beth Broeren gave the background and the City's objective with regard to rezoning the property. She stated that the Planning Commission recommended denial of this request by a 5 to 3 vote. However, she stated that City staff recommended approval of the rezoning because the change from industrial to residential zoning, along with the plans for development of homes and infrastructure on the property, would result in significant benefits to the City. Therefore, rezoning the property would promote both the Transportation Master Plan and the Parks and Recreation Master Plan, as well as the City's plans for greenways and floodways. Also, she stated that although staff had initially recommended denial of the application because of a concern of a lack of industrial-zoned property in the City, more industrial-zoned property was now available in the City than originally believed due to a change in use on another large property located near County Line Road.

Council President Smith opened the public hearing for comments regarding this request:

The following people spoke:

- Al Jimerson spoke on behalf of the Huntsville Airport Authority to oppose the rezoning.
- Mike Sheehey spoke in opposition to the proposed rezoning.
- Connie Spears spoke in opposition to the proposed rezoning.
- Robert Kindall stated that he had been opposed to the rezoning but was now tolerant
 of the rezoning as apartments were not built on the property.
- Bebe Oetjen asked if the Planning Commission had reconsidered its vote, and was informed that it had not.
- Terri Johnson asked if the development of the property would occur in phases over time, and was informed that a phasing plan was in place for the property.

Council President Smith closed the public hearing. Council Member Shaw made a motion to approve the rezoning, and Council Member Powell seconded his motion.

Council Member Shaw stated that he believed that the rezoning would not be in the best interest of the City, school system, or airport and was not the best long-term choice for the City.

Council Member Seifert stated that he was a member of Planning Commission and had voted to deny the rezoning. However, he stated that due to new information, he now believed significant benefits to the City would result through the rezoning.

Council Member Wroblewski stated that she did not believe residential rezoning was suitable for the property because of industrial uses located close to the property. She stated that she supported the recommendations of the School Board, Planning Commission and the Airport Authority not to rezone the property.

Council Member Overcash spoke in favor of the rezoning due to the Planning Department's findings and recommendations, as well as the development and infrastructure plans for the property.

Council Member Powell asked staff how many students could live at each house in the future development. Ms. Broeren showed different student generation rates for different types of housing, and she indicated that the townhomes planned for the property would result in a lower rate of new students. Mr. Powell invited comments from School Board President Ranae Bartlett, who estimated a high number of students per home in the development and spoke in opposition to the rezoning because the number of new students each year, school system-wide, had been outpacing school building capacity. Mr. Powell also invited comments from the applicant's representative Mr. Joey Ceci, who estimated a low number of students per townhome in the development and who noted that due to infrastructure and utility construction, it was likely that no new students would live there until 2021.

Council President Smith spoke in favor of the rezoning. He stated that more people living in homes at that location and paying property taxes would outweigh the impact of new students living there.

Having no further comments, Council President Smith closed the floor and entertained a vote from Council.
