REVENUE OPTIONS:

Council discussed enacting of an additional ½ cent sales tax for capital projects that would be included in the General Operating budget.

Council discussed having town hall meetings to inform the citizens on the need for the tax increase and how the funds would be spent.

Mayor Trulock also gave a powerpoint presentation revenue growth.

MISCELLANEOUS OTHER BUSINESS:

Council discussed the plan for the gas lights on Church Street and Front Street. This issue will be addressed at the April 8, 2013 Council meeting.

City Engineer Gary Chynoweth advised Council of information he has received regarding an ALDOT grant program for sidewalks, street lights and landscaping projects. The deadline for submit applications is June 28, 2013. Council Member Clark will work as the liaison this grant application with Engineer Chynoweth.





District One





District Two






