**Miscellaneous discussions:**

Director of Development Services, Mary Beth Broeren spoke to the committee regarding development of the Wann property on Mill Road. It was also noted that the Wann family sold the property behind City Hall to be developed. The development will contain multi-family properties. The committee expressed concerns about the west side of the cemetery property which is on the north side of Mill and asked if the developer would consider paying for fencing. Mrs. Broeren noted, that as of this meeting, she had not received plans from the developer.

Mrs. Broeren also mentioned that the Wann family would be donating the family home, located on Mill Road and the land on which the house stands to the City of Madison. The family requests that the City would turn the home into a museum.

Public Works Director, Kent Smith spoke to extending Place 6, Colby Smith appointment of limited term to be removed. Request will be presented to City Council for approval.

Kent also provided an update on the fence damage. He stated that the damage was reported to AMIC, City's insurance and that a contractor was hired to replace the section of damaged fence at the Madison Cemetery facing Hughes Road.

**Elections:**
